What Is Covered	Defects in material and/or workmanship in a new cover.	Failure under normal use and service condition with proper care and maintenance.
How Long	Two years from date of original purchase.	Twelve years from date of original purchase.
What We Will Do	We will replace or repair, at our option, any part or parts which to our satisfaction prove defective.	We will replace your cover at a percentage of the current list price; customer to pay for usage on a pro rata basis for each month of ownership or part thereof up to a total of 144 months.
What We Will Not Do	Warranty conditions will not be honored if: <ul style="list-style-type: none"> a) Cover has been subject to misuse, (e.g. not drum-tight), constant on and off through the year, alteration, neglect, abuse or accidents including those caused by animals, sharp or rough coping, burns, machinery or other foreign objects. b) The water level of the pool falls more than 18" below the pool top during the snow season. c) A standard or rectangular cover is used on other than a rectangular pool for which it is sized for. d) The cover is used on a pool other than the original installation or cover is not properly fitted to pool. e) Cover is not used or installed for its stipulated purpose in accordance with manufacturer's instruction. f) The cover pump (solid safety cover) has not been used to remove accumulating surface water. 	
What Customer Must Do	To be considered for repair or replacement, original purchaser should return the cover FREIGHT PREPAID with springs removed in a clean, dry condition, along with proof of purchase indicating date of purchase, from whom purchased and warranty number. For more information on warranty service call our customer service department prior to return at (800) 446-3926. Covers will not be accepted for warranty consideration without a return authorization from Meyco Pool Covers.	
Other Conditions	All repairs or replacement under warranty shall be F.O.B. Moore, SC or Melville, NY. Meyco shall not be liable for freight, installation, service or labor costs. A Return Merchandise Authorization Number (RMA) must be received prior to sending in cover. Product will be refused without an RMA#.	

Note: Cover pumps (solid safety cover) are not covered by Meyco but by a separate manufacturer's warranty. Unless required by applicable law, this warranty sets forth all responsibilities of Meyco Pool Covers. Meyco shall not be responsible for warranty except as set forth herein.

State Law Rights This warranty gives you specific legal rights as limited herein. You may have other rights that vary from state to state

Twelve Year Warranty is for MeycoLite Mesh, RuggedMesh and PermaGuard covers only.

This warranty is written free from "legaleze" and in conformity with the warranty format recommended by the Federal Trade Commission and in keeping with the intent of the Magnuson-Moss Warranty act.

Attach sales receipt or copy of cancelled check to warranty certificate and file for future reference.

Do not drag cover over any abrasive surface, carry cover to pool area.

Dragging cover over concrete, brick or other abrasive surfaces will cause damage not covered by our warranty.

Be careful not to catch the cover material on springs or anchor necks.

This could cause small pulls and tears in the material not covered by the warranty.

Check pool water level – it must be within 18” of the top of the pool and must not fall lower during the winter (snow) season.

Low water level will cause undue stress on the cover and could cause damage not covered by our warranty.

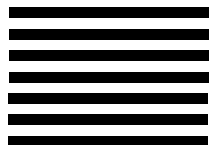
