

# MEYCO SAFETY POOL COVER LIMITED 12 YEAR CERTIFICATE OF WARRANTY

Meyco Products Inc. warrants to the original owner of this product that if the cover should fail due to a separation of sewn joints or material, within 12 years after the date of sale to owner, then Meyco will repair or replace the cover at its discretion, subject to the following terms.

This Warranty is only valid if it has been registered with Meyco within 30 days after installation. To register, please return the Warranty card to Meyco or go to [meycocovers.com/registration](http://meycocovers.com/registration). Meyco will not be obligated to respond to any claim where the warranty has not been registered as required above.

Meyco will not be responsible for and this Warranty will not apply to any damage to the cover caused by but not limited to any of the following:

- Impact from other objects including but not limited to falling objects.
- Animal damage, including but not limited to pets, farm animals, rodents or other wild animals.
- Neglect or abuse of the cover. Cover must remain drum tight while in use.
- UV or other damage due to solar reflection.
- Hurricane, flooding, hail or other extreme weather.
- Failure to install the cover and/or maintain the cover in full compliance with the Meyco Pool Covers Safety and Owners' Manual and Installation Instructions.
- Contact with the cover by any decking or coping that is rough, unprotected or unsanded.
- Storage or placement of any objects on the cover.
- Exposure to excessive heat or cold, sparks (i.e. from fire pits, fireworks, grills, etc.), or to fire.
- Failure to maintain proper pool water pH and/or excessive Chlorine or other chemicals applied in excess of their respective labeling.
- Damage to the cover due to Chlorine or other chemicals applied directly to, over, or through the cover.
- Failure to maintain water level of the pool within 18" from the main deck at all times that cover is in place.
- Year round use of cover or outside of the normal "season" and/or daily use of the cover.

"Season" is defined as winter use between the months of September-June. Each season is equivalent to 1 year. Using the cover all year round would constitute excessive use and will age the cover more rapidly and will void your warranty. Any of the above events will VOID THIS WARRANTY IN ITS ENTIRETY.

Discoloration, fading or irregularities in print or pattern are NOT covered by this Warranty.

If a valid warranty claim is received by Meyco during the first three years from the date of original purchase we will, at our discretion, repair or replace the cover, without cost to the owner. All Warranty claims require cover to be returned to Meyco Pool Covers FREIGHT PREPAID for inspection.

For any valid warranty claim received by Meyco after that time, but prior to the expiration of the warranty, owner will be responsible for a portion of the cost of the repair or replacement, based on the retail price of a new cover of the same dimensions or current repair pricing, according to the following table.

Age of cover 4-5 years old 33%	Age of cover 8-9 years old 66%
Age of cover 5-6 years old 42%	Age of cover 9-10 years old 75%
Age of cover 6-7 years old 50%	Age of cover 10-11 years old 83%
Age of cover 7-8 years old 58%	Age of cover 11-12 years old 91%

**PLEASE NOTE:** AZ,CA,FL,NM,HI and TX have a higher UV index which may cause your cover to age more rapidly depending on the amount of use.

Under no circumstances shall Meyco be responsible for labor costs associated with the removal, shipment or re-installation of any cover. Meyco is also not responsible for any other expenses, consequential, incidental or otherwise.

**IMPORTANT SAFETY INFORMATION:**

Your Meyco safety cover should be inspected regularly. If the cover appears torn or damaged, then you must STOP using it as a safety cover. Make sure your pool is maintained and protected in accordance with applicable state or local barrier codes. Other things to look for include, threads being broken or missing, wear of the reinforcing strips at the bottom of the cover, webbing becoming frayed, excessive fading of material or material becoming stiff or brittle. DESPITE THE AGE OF THE COVER OR THE AMOUNT OF TIME LEFT ON THE WARRANTY, these are all signs of a cover that may no longer be considered a safety cover and it should be replaced or repaired immediately.



**WARNING: AVOID DROWNING RISK**

- Remove cover completely before entry of bathers – entrapment possible.
- Non-secured or improperly secured covers are a hazard.
- Do not walk on cover except in an emergency.
- Mesh covers: Keep cover drum tight to avoid standing water.
- Solid Covers: Remove standing water – child can drown on top of cover.
- Failure to follow all instructions may result in injury or drowning.

**RECOMMENDED PROCEDURES  
for your Meyco Pool Cover**

- DO NOT DRAG COVER OVER ANY ABRASIVE SURFACE; CARRY COVER TO POOL AREA.  
Dragging cover over concrete, brick or other abrasive surfaces will cause damage not covered by our warranty.
- BE CAREFUL NOT TO CATCH THE COVER MATERIAL ON THE SPRINGS OR ANCHOR NECKS.  
This could cause small pulls and tears in the material that are not covered by the warranty.
- CHECK POOL WATER LEVEL; IT MUST BE WITHIN 18” OF THE TOP OF THE POOL AND MUST NOT FALL LOWER DURING THE WINTER (SNOW) SEASON.  
Low water level will cause undue stress on the cover and could result in damage not covered by our warranty.
- PERSONALLY HAND THE WARRANTY CARD AND CARE OF MEYCO COVER INSTRUCTIONS TO THE CUSTOMER.

**IMPORTANT**

MEYCO Swimming Pool Safety Covers typically are designed with anti-abrasion strips for added protection at typical wear points where webbing straps ride over the smooth coping edge. However, extra precaution must be taken by the installer or pool owner in areas with rough coping or sharp corners. It is recommended that additional padding (vinyl, rubber sheeting or carpet remnants) be used to prevent excessive wear. MEYCO PRODUCTS is not responsible for damage caused by rough coping or sharp edges.
